- 編製統計數據和證券持有人資料;
- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關目的及/ 或使本公司及H股證券登記處能履行對證券 持有人及/或監管機構承擔的責任及/或證 券持有人不時同意的任何其他目的。

3. 轉交個人資料

- 香港聯交所、香港證監會及任何其他法定監 管機關或政府部門或遵照其他法例、規則或 法規;及
